HEREBY DECIDES:

Article 1. To amend the License for establishment and operation No. 125/GP-UBCK dated May 30, 2018 issued by the Chairman of the State Securities Commission to Techcom Securities Joint Stock Company with the following contents:

Charter capital: VND 27,744,533,250,000 (In words: Twenty-seven trillion seven hundred forty-four billion five hundred thirty-three million two hundred fifty thousand Vietnamese dong)

Article 2. This License shall take effect from the date of signing and is an integral part of the License for establishment and operation No. 125/GP-UBCK dated May 30, 2018 issued by the Chairman of the State Securities Commission to Techcom Securities Joint Stock Company.
