Pursuant to the Law on Securities dated November 26, 2019

Pursuant to the Law amending and supplementing a number of articles of the Law on Securities, the Law on Accounting, the Law on Independent Audit, the Law on the State Budget, the Law on Management and Use of Public Assets, the Law on Tax Administration, the Law on Personal Income Tax, the Law on National Reserves, Law on Handling of Administrative Violations dated November 29, 2024;

Pursuant to the Government's Decree No. 155/2020/NĐ-CP dated December 31, 2020, detailing the implementation of a number of articles of the Securities Law and the Government's Decree No. 245/2025/NĐ-CP dated September 11, 2025, amending and supplementing a number of articles of Decree No. 155/2020/NĐ-CP;

Pursuant to Decision No. 07/QĐ-HĐTV dated July 09, 2021 of the Members' Council of the Vietnam Stock Exchange promulgating the Charter of organization and operation of the Ho Chi Minh Stock Exchange;

Pursuant to Decision No. 22/QĐ-HĐTV dated March 16, 2026 of the Members' Council of the Vietnam Stock Exchange on the promulgation of the Regulations on listing and trading of listed securities;

Pursuant to the application dossier for amendment to the listing registration of Techcom Securities Joint Stock Company;

At the request of the Director of the Listing Management Department.

DECISION:

Article 1. Approval of the amendment to the listing registration of Techcom Securities Joint Stock Company with the following details:

- Type of securities: Common shares
- Securities code: TCX
- Par value: VND 10,000 per share
- Number of listed securities before the amendment: 2,773,896,803 shares (*In words: Two billion seven hundred seventy-three million eight hundred ninety-six thousand eight hundred three shares*)
- Additional listed securities: 556,522 shares (*In words: Five hundred fifty-six thousand five hundred twenty-two shares*)
- Value of additional listed securities (at par value): VND 5,565,220,000 (*In words: Five billion five hundred sixty-five million two hundred twenty thousand Vietnamese dong*)
